## Depth and diversity in 2008 Australian Scholars

The U.S. Ambassador to Australia, Mr Robert D. McCallum, Jr., was impressed by “the breadth, depth, variety and diversity of the new Fulbright Australian Scholars”, when he congratulated and welcomed them into the Fulbright family at the Fulbright Presentation Dinner on 13 March.

The Presentation Dinner, the first to be held in Western Australia, was hosted by the University of Western Australia at Winthrop Hall, with Edith Cowan University’s Western Australian Academy of Performing Arts providing a performance by percussion ensemble *Defying Gravity*.

The 2008 Scholars were announced by the Australian-American Fulbright Commission’s Executive Director, Mr Mark Darby. In presenting the Scholars, Mr Darby said the successful Scholars truly demonstrated the breadth and diversity in research amongst Australia’s brightest (see list on page 4).

The Scholars were presented to and congratulated by the Honorary Co-Chair of the Fulbright Commission, Ambassador McCallum; the Western Australian Minister for Education and Training, the Hon. Mark McGowan MLA; and National President of the Australian Fulbright Alumni Association, Dr Tony Worby.

In congratulating the Scholars, Ambassador McCallum spoke about the importance of

the Fulbright Program as a premier exchange program.

“The importance of this program in Australia to the United States can not, to my view, be overstated because it provides a certain texture and strength to the fabric of good relations that have existed for so many years between our two countries.”

“The studying abroad, the exchange of ideas, the exchange of information, the familiarity which that breeds, have enriched both our nations, over that extended period of time,” said Ambassador McCallum.

The Western Australian Minister for Education and Training, Mark McGowan, used the occasion to announce the WA Government’s support of the Fulbright WA Scholarship and the importance of Western Australia’s relationship with the U.S.

“We have a long history of a relationship with the United States, that has many exciting parts to its history but it was very much cemented in the worst days, the darkest days, of the second world war, back at the end of 1941...The relationship has continued since that point in time and we have always valued that relationship – it has always been something that is deep and abiding and we value very much in Western Australia and would like to see continue,” said Minister McGowan.

It has been a busy start to the year with the Fulbright Presentation Dinner held in March for the first time. The primary reason for this move was to allow earlier notification of Australian Fulbright Scholars and thus assist their preparation for the United States.

Our thanks to the University of Western Australia, and Edith Cowan University and the Western Australian Academy of Performing Arts for their support in hosting the Presentation Dinner in Perth.

It was a pleasure to have Ambassador McCallum and Mrs Mimi McCallum, and The Hon. Mark McGowan, WA Minister for Education & Training, as our guests of honour.

The event not only presented the Australian Fulbright Scholars, but also celebrated the connection of WA with Fulbright and the

United States through the establishment of the Fulbright WA Scholarship Fund.

Our thanks and congratulations to all the donors and the Fundraising Committee who have made this possible. With a target of \$1 million, to date \$986,000 has been received or committed to this fund to support two Fulbright WA scholarships in perpetuity.

The Fulbright Board and U.S. Consul General to Perth, Dr Ken Chern, hosted a lunch on the Friday following the dinner to personally thank donors and committee members. We were pleased that The Hon. Julie Bishop, Deputy Leader of the Opposition and local member for Curtin, could join us for this celebration.

I look forward to meeting you around Australia at various Fulbright state events during April / May. We will also be developing U.S. events with our new Fulbright Alumni Chapters in October, following the arrival of this year's Australian Scholars.

"Events like tonight are part of making sure that deep relationship continues. A further part in making sure it continues is the new endowment fund for the Fulbright WA Scholarship. The fund is being contributed to not just by sponsors, but it is also being contributed to by a \$500,000 donation from the West Australian state government. We are very proud and pleased to be a part of it."

"Congratulation to all the people who have been selected, it's a wonderful opportunity to go to the United States to study and learn, it will build the relationship, it will make sure you are enriched and hopefully the United States is enriched by your presence," stated Minister McGowan.

Ambassador McCallum also used the occasion to acknowledge the work by former Fulbright Commission Chair, Professor Peter Coaldrake, Vice-Chancellor of Queensland University of Technology, with a certificate of appreciation for his time as a Board Member and Chair.

Professor Coaldrake was a Board Member from August 2003 to December 2007 and served as Board Chair for three of those years. He was twice a Fulbright Scholar, in 1981 as a Postdoctoral Fellow and in 2001 as a Senior Scholar Fulbright Alumnus.

"With this background he has brought great energy and a wealth of knowledge to the position, and was responsible for guiding

the establishment of the Fulbright Queensland Scholarship and has been just as active in encouraging Vice-Chancellors in other states to follow suit," stated Ambassador McCallum.

In accepting the certificate, Professor Coaldrake highlighted the State Scholarships as a major achievement of the Board during his time as Chair. "Being able to contribute in the Board role has been a real pleasure and a really easy job," he said.

At the conclusion of dinner it was announced the 2009 Fulbright Presentation Dinner will be hosted by the University of Tasmania in Hobart.

the darkness of World War Two were still fresh, and Bill Fulbright's dream of a world program was barely three years old. "He felt a kinship towards Australia and he really enjoyed the Australian people and their sense of humour," Harriet recalls. "Fulbright had a wonderful sense of humour. And Australians and Americans share the same language, the same value systems in many, many ways."

"Australia," she says of the Australian-American Fulbright Commission, "is outstanding in many ways. Take minorities, for example. Australia is outstanding in that it specifically has a grant for the indigenous population. They also have a grant specifically for the arts."

The Australian program, she believes, is "moving in the right direction" and overall is very exciting. But what's missing, as always, is additional funding. "I really want to see the program increased. The U.S. government claims it has increased our funding, but in reality they have barely kept up with inflation. They have not kept up with the increased cost of transportation, nor with increasing interest in the Muslim countries of the world."

Given her optimism, and enthusiasm for carrying on Bill Fulbright's legacy, I wonder aloud if Harriet sees any shortcomings in the Fulbright scheme, things that could have been done better. She doesn't hesitate. "I think we should have started long before this with the Muslim populations. The Middle East, we have paid virtually no attention to them until recently, and to our detriment," she says. "It's a priority now, and a very difficult one, because we do now have a program in Iraq but it's not a real Fulbright program because it's only the Iraqis coming to the U.S."

True to her character, Harriet Fulbright is already working on a solution. "We've got a lot of Muslim alumni," she says, "and we've got to learn better how to call on them." The Middle East might deter most Americans these days, but not the indomitable global ambassador of the Fulbrights. "It's a wonderful model," she says glowingly of her husband's achievement, "among the very best."

On her recent whirlwind trip to Australia, the President of the J. William and Harriet Fulbright Center, Harriet Fulbright, took an hour from her hectic schedule to speak with Sydney author and journalist **Tony Maniaty**. She is, he found, a gently-spoken tower of strength, with plenty of opinions and fresh ideas.

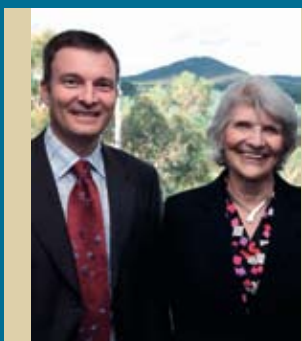
**Harriet Mayor Fulbright** is impressively calm. My first thought on meeting this eloquent and charming woman is what a magnificent foil she must have been to her dynamic late husband, Bill Fulbright, the feisty Democrat senator who drew both

praise and criticism for his opposition to the Vietnam War, who mixed high values and political clout to stunning effect.

"Bill Fulbright said it's very important to stay close and understand your friends, but it's more important to stay closer and understand your enemies. On a regular basis he invited the Ambassador of the Soviet Union to his home for supper and they became very close. I'm convinced that in times of real world tension, their relationship played a huge and mitigating force in what could potentially have been an explosive situation."

Given the complexities facing the world today, I ask whether she thought her husband's postwar vision for promoting peace through international programs had succeeded, or failed? "I think both. We did not have a Third World War, and we have almost 300,000 Fulbrighters in 140 different countries around the world. And every single one I've spoken to talks about mind expansion, greater understanding, completely new career paths, and their worldwide networks." The accumulated impact, she says proudly, is powerful.

The Australian program began in 1949, when bonds forged with America in

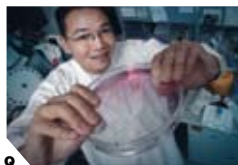
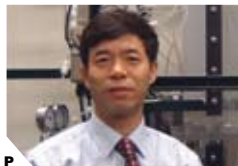

## 2008 Fulbright Symposium Healthy People, Prosperous Country

Governments will be challenged to consider how best to invest the wealth generated by Australia's current economic prosperity in the future health of the country, when Flinders University hosts the Fulbright Symposium in July 2008.

Flinders University and the Co-operative Research Centre for Aboriginal Health (CRCAH) were awarded hosting rights in January, following a nationwide competition between universities and other institutions.

Entitled *Healthy People, Prosperous Country* the Symposium will be held from 10-11 July at the National Wine Centre in Adelaide.

The symposium will examine how to encourage whole-of-government action to promote health and wellbeing locally and

nationally, and explore ways in which existing inequities in the health status of different groups in the population can be addressed.

Deputy Vice-Chancellor (Research), Professor Chris Marlin, said universities have a major role to play in fostering debate on issues of importance to the community.

"Australia is experiencing a period of sustained economic growth and the country must decide how best to invest some of that prosperity in ways that maximise the health outcomes for our community," Professor Marlin said.

"How do you ensure that the investment we make in health infrastructure and services achieves equitable outcomes across the various sectors of society?" he asked.

"The Symposium will also be one of the first opportunities to review the findings of a major research project by the World Health Organisation's Commission on Social Determinants on Health, on which Australia has been represented by Flinders University's Head of Public Health, Professor Fran Baum, since 2005."

Professor Marlin said the symposium will bring together experts from both Australia and the United States and comes at an important time, given the previous Federal Government's intervention program into Aboriginal health.

The symposium will attract participants from a wide range of professional fields.

# Applications now open for Fulbright Alumni Initiative Grant

The Fulbright Alumni Initiative Grant aims to help build individual Fulbright experiences into long-term institutional collaboration and linkages.

The grant provides A\$10,000 to support a Fulbright Alumnus' work with their original home and host institutions to develop innovative projects that will foster institutional linkages and sustainable, mutually beneficial relationships.

The host institution does not have to be the primary host of the Alumnus during their Fulbright Scholarship but can be a secondary host, or a short term host they develop close links with during their Fulbright Program.

The Alumni Initiative Grant inaugural winners in 2007 were: Elizabeth Madin from

the University of California, Santa Barbara (UC - SB) and Scott Carroll, University of California, Davis (UC - Davis). Elizabeth, from the Marine Science Institute at UC - SB, came to Australia to develop collaboration with the Australian Institute of Marine Science (AIMS) on ocean ecosystems. Scott Carroll, with the Centre for Population Biology at the UC - Davis, worked with The University of Queensland to collaborate on Evolutionary Conservation Biology.

The visit can be between three to twelve weeks and the grant supports any activities which achieve both short and long term objectives of ongoing institutional collaboration. It does not support individual research.

The application needs to be submitted by the Alumnus; however it also has to be supported by letters of application from the home and host institutions, with an expectation that the institutions will also contribute some funds and/or in kind support. If some collaboration is already in place, the proposal should clearly articulate how this grant will add value to what has already taken place and build the platform for future collaboration.

Applications are now being accepted and close on 30 April 2008.
