New Fulbright Scholarships for Australians

For the first time, an American university will sponsor Fulbright Scholarships in the United States for Australians.

A landmark partnership between the Australian-American Fulbright Commission and Kansas State University (K-State) will give two Australian researchers each year the opportunity to undertake a Fulbright Scholarship at K-State. The agreement will run for five years.

One scholarship will be a Fulbright Distinguished Chair, the Distinguished Chair in Agriculture and Life Sciences. It will attract a key researcher in the area of agriculture and life sciences, subjects that are of key importance to both Australia and the U.S.

In welcoming the announcement, Dr Tangerine Holt, Executive Director of the Australian-American Fulbright Program said that these scholarships will be a great opportunity for the researchers who receive them, and they also will forge a new link between Australia and the U.S.

"The essence of the Fulbright program is that it gives Fulbright Scholars and the institutions who host them the opportunity to build and develop partnerships and friendships through mutual understanding, educational and cultural exchange," Dr Holt said.

Ambassador Jeffrey Bleich from the U.S. Embassy announced the new Kansas State University scholarships and also took part in the presentation to the new Scholars.

"Fulbright's spirit remains the bedrock of our relationship. We are bound by common values. In a world with billions of people, there will never be enough laws, or guns, or fences, or bombs to keep us secure," Ambassador Bleich said.

"It is the social ties – the faith that other people value their lives and their children and want peace just as we do – on which humanity's future rests. These things are not legislated – they are formed through what Fulbrighters do – the thousands of interactions and tender connections among people."

"By pursuing this exchange you tighten our connections to one another, you bind us more tightly across a vast planet, and in doing so you make us and our world more secure."

The presentations to the Scholars were made by Mr Peter Varghese, Secretary of the Department of Foreign Affairs and Trade; Ambassador Bleich and Professor John Leslie, from K-State University, who is a Fulbright Alumnus.

2013 Fulbright Symposium to focus on Soft and Smart Power

How an educational and cultural exchange program impacts on society over generations will be explored in the 2013 Fulbright Symposium.

Entitled Soft Power, Smart Power: the Multiplier Effect of Educational and Cultural Exchange, the event will be held in Canberra in August 2013 to coincide with celebrations for the Centenary of Canberra.

The Fulbright Commission will host the 2013 Fulbright Symposium in partnership with key stakeholders. For Senator Fulbright, it was obvious that there was an essential link between education, the exchange of ideas, and the creation of a world community through brain circulation harnessing the smart power, goodwill and strengths of us all. The Fulbright Program's legacy, credibility and legitimacy are an important source of soft power and smart power. As intangible assets our Fulbright landscape is embodied by dynamic personalities, innovative research, and an openness to share and learn about each other's culture, political values, institutions, and policies.

Mr Tom Healy, Fulbright Foreign Scholarship Board (FFSB) Chair, will be among key speakers at the event.

The aims of the Symposium are to showcase the impact of soft power through the Fulbright program across key themes of leadership and diplomacy, culture, educational partnerships, public policy, arts and culture, science and innovation. It will also demonstrate how excellence and innovation have led to partnerships, collaborations and linkages that are beyond the individual. Thirdly, it will share best practice which benefits the individual, industry and practice.

It will be held at the Canberra Convention Centre on 21- 22 August, with a gala dinner to be held at the Gandel Hall, National Gallery of Australia.

Engineering. To undertake PhD research into the dynamic stall of pitching wings, and apply it to the growing area of wind energy, studying wind turbine dynamic stall, for a year at Princeton University.

Ocean modelling. To undertake research to improve simulations of ice shelves, in a twelve month collaboration with the University of Texas at Austin. This will lead to improved understanding of ice shelf melting, ice sheet flow and global sea level rise.

Non-profit Scholarship awarded to two winners

The announcement of the first winner of the Professional Scholarship in non-profit leadership was doubly exciting this year with not one, but two recipients called to the stage to be presented with their certificates, letters and pins.

The caliber of the applicants was so high that the sponsors, the Origin Foundation, and supporters, the Australian Scholarships Foundation, decided to sponsor two winners rather than one.

Sean Barrett, Head of the Origin Foundation, said, "The quality of applications for the Fulbright Scholarship were exemplary, making it impossible to choose just one candidate out of an astounding variety of applicants. The program applications were of such a high quality we had no choice but to award two scholarships, exceeding Origin Foundation's initial commitment to provide funding for one scholarship annually."

The two recipients of the inaugural Fulbright Professional Scholarships in Non-Profit Leadership, sponsored by the Origin Foundation and supported by the Australian Scholarships Foundation are Dr Tessa Boyd-Caine and Mr Andrew Tyndale.

Dr Boyd-Caine is the Deputy Chief Executive Officer of Australian Council of Social Service (ACOSS), the peak body of

the community services and welfare sector. Through her Fulbright, Dr Boyd-Caine will go to New York and Washington DC for four months to research issues around how non-profit organisations can strengthen and lead the trust and confidence in which this sector is held. While in the U.S. Dr Boyd-Caine will investigate the work of the Foundation Center, an organisation instrumental to building openness within the American non-profit sector, and its partnership with the National Center for Charitable Statistics.

Mr Andrew Tyndale, Director and Founder of Grace Mutual Limited, will go to The

Milken Institute in the U.S. for four months and will further his research in social investment. Grace Mutual Ltd is a not-forprofit (NFP) organisation that was formed to generate financial solutions for other NFP organisations, principally around capital and assets.

Mr Tyndale considers that social investment is a new field in which commercial investment is directed to investments which generate good social outcome. These may include community enterprise, employment, or environmental or social inclusion.

Fulbrighter awarded top PhD fellowship at U.C. Berkeley

Fulbright U.S. Scholar, Cecelia Prator updated us with her plans following her Fulbright at the University of Queensland.

During my Fulbright experience I was fortunate to experience first hand the demands of full time research. I found that the creativity required for complex problem solving as well as the unpredictability of working in a laboratory was exciting. This inspired me to continue my training as a scientist after the Fulbright program by applying to PhD programs.

I applied to a few programs in the US as well as an international PhD program at the Institut Pasteur in Paris, France which required a weeklong interview process, several meetings with scientists from the Institut Paster as well as a presentation in front of a scientific committee. I learned I was accepted to this program shortly after my return to Australia.

At the same time I learned I was accepted to the University of California, Berkeley and awarded a Chancellor's fellowship which is chosen from the top 4 per cent of admitted graduate students. After a very difficult decision I have decided I will be starting at UC Berkeley in August 2013 studying the molecular mechanisms of grapevine leafroll associated virus transmission in mealybugs which will have important implications for agriculture in the US.

Fellow scholar Sam Shockley will also be heading to California and starting a PhD program at Caltech after her Fulbright in Australia and we have tentative plans to tackle the John Muir trail together in the Sierras when we find time to escape from the lab.

Excellence in Achievement Award for AFAA Chapter Chair

Associate Professor. Iain Butterworth, Chair of the AFAA Victorian Chapter, was recently presented with an "Excellence in achievement by an individual" award by the Secretary of the Victorian Department of Health, at the Department's annual Achieving the Best Awards ceremony. Iain has sent us a report of his Fulbright, and the role it has played in his career.

It is almost ten years exactly since I travelled to Canberra in May 2003 for the National Awards Dinner and induction program. I recall feeling a sense wonderment and elation. I called a close friend in the US, a university professor; she burst into tears. I knew then that my life was about to change. With the full support of my then government employer, I went to Berkeley to study with Prof Leonard Duhl. A psychiatrist and urban planner, Len was co-founder of the WHO Healthy Cities program. Since 1986, some 10,000 cities around the world have drawn on this approach. I investigated the potential for Healthy Cities programs to demonstrate progress in better connecting people with their local communities and significant places.

I returned to Australia with a detailed understanding that the process of engaging stakeholders in the development of indicators was more important to policy implementation than the indicators themselves. I drew heavily on this experience in my subsequent work. I returned with insights that enriched my engagement with hundreds of practitioners, policy makers and students.

I was offered a position at Deakin University, where I remained for five years. For four years I conducted a Healthy Cities Short Course, which featured Prof Len Duhl in 2005. After exploring briefly the life

of a consultant, I returned to government in 2010 in my current role. Iain has just been appointed as Honorary Associate Professor at the University of Melbourne.

My expectations - of the Fulbright experience and my role within it - were dramatically exceeded. The Fulbright has had an indelible effect on my career prospects, in the sense that employers have recognised that Fulbright Scholars can bring a creative edge to their work.

A wealth of experiences

Fulbright U.S.Scholar Sam Shockley talks about how her Fulbright adventure and how it has impacted on her life.

Upon opening the Fulbright acceptance email it is easy to instantly envision yourself simultaneously curing cancer and breaking down any existing walls of cultural prejudice, of course all while getting an Australian tan. But when the reality upon arrival is a complete overhaul of your research proposal, long hours and weekends in the lab, and lab mates who love American pop culture perhaps even more than you, where is the Fulbright experience?

I came to Canberra and the A.N.U. to develop novel and concise chemical syntheses for marine natural products found on the Great Barrier Reef. Initially I proposed to devise a synthetic route for a recently isolated compound that had yet to be created in the lab. However due to an exciting opportunity for collaboration with the U.S. National Institute of Health, the focus of my project shifted when I came to Australia. Over the past nine months of my Fulbright fellowship I have optimized a previously inefficient synthesis of Lamellarin W and worked to modify the synthetic natural product so as to improve its drug potential, which will be tested by my collaborators.

The field of organic total synthesis is notorious for its grueling hours, which at first made me feel a strong obligation to devote all of my time to my project; to make progress in my field that was worthy of being funded by the Fulbright organization. But doing so left me unfulfilled and I felt like I was not engaging with Australia enough.

When the chance arose to road trip the entire east coast with fellow Fulbrighter, Ceci Prator, I decided it was time to experience Australian life outside of the lab. What I found on our three week long trip with only a tent and no itinerary was that the Fulbright mission was alive even when taking time for yourself, not just while working hard at the bench. From sharing drinks with fellow scuba divers on a live aboard boat to conversing with the owners of a borrowed campfire stove because we were so ill-prepared, Fulbright's ideas of mutual understanding and exchange rang true – we were sharing our experiences as Americans, breaking down our research to the people and listening to what the locals had to say about their country.

After returning to Canberra, I began to take more time to explore and engage with Australia in everyday life. From training for the Canberra half marathon with my lab mates and Fulbrighter, Mark O'Donnell, to posing for the cover of Australian Journal of Chemistry, I have found myself doing things I never predicted in my Fulbright application but equally deserve a place in my final report amongst my research achievements.

So my advice to the outgoing Australian Fulbright scholars is to relax and find an equilibrium between your research and a wild exploration of America. The Fulbright experience is just as much in the times of personal adventure as it is in the moments of study. The Fulbrighter is the newsletter of the Australian-American Fulbright Commission.
